1. I, AS MY CHILD(REN)'S PARENT AND/OR LEGAL GUARDIAN, HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE DONG HANH CLC, its directors, officers, employees, agents, and volunteers (hereinafter referred to as "Releasees") from any and all liability for any loss, damage, or claim, or demands therefor, on account of any injury to the person or property or resulting in death of my Child(ren), whether caused by the negligence of the Releasees or otherwise, while my Child(ren) is (are) in, upon, or about any premises, property, equipment or any facilities being used by Dong Hanh CLC or participating in any associated DONG HANH TAY NAM REGIONAL GATHERING activities conducted by or for Dong Hanh CLC.

2. I HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees, and each of them, from any loss, liability, damage or cost they may incur due to my Child(ren)'s presence in, upon or about any premises, property or equipment being used by DONG HANH CLC, or in my Child(ren)'s participation in DONG HANH TAY NAM REGIONAL GATHERING activities, whether caused by the negligence of the Releasees or otherwise.

3. I HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE to my Child(ren), due to the negligence of Releasees or otherwise, while in, about or upon any premises, property or equipment being used by DONG HANH CLC, and/or while participating in any related DONG HANH TAY NAM REGIONAL GATHERING activities.

4. The releases stated herein and the terms of this Release and Waiver of Liability and Indemnity Agreement shall be binding on any personal representative, assigns, heirs or next of kin of my Child(ren).

5. I acknowledge, understand and declare that, to the best of my knowledge, my Child(ren) is (are) in good physical condition and has (have) no disease or injury that would be aggravated by participating in DONG HANH TAY NAM REGIONAL GATHERING activities.
